Introduction

- IFFCO established in 1967 with the support of ACDI/VOCA and NCBA CLUSA in collaboration with the Government of India to make India self-sufficient in food production through Green Revolution.
- Wholly Owned by the Member Cooperative Societies where member cooperatives contributed willingly to the share capital of IFFCO.
- IFFCO operates on a farm-centric approach: of the farmers, by the farmers, and for the farmers.
- Largest Producer & Marketer of Fertilisers in India, with association of about 36,000 member societies & approx. 50 million farmers.
- IFFCO has been ranked as the World's No. 1 cooperative in the 2023 edition of the World Cooperative Monitor, based on the ratio of turnover to GDP per capita.

IFFCO at a Glance

- ❖ As one of India's largest fertilizer brands, main business of Member Societies is to sell Quality Fertilizer of IFFCO to farmers, which is their key source of income, and it keeps them economically viable.
- ❖ From last 24 consecutive years IFFCO is paying a 20% dividend on paid-up share capital to its member societies. There is a provision kept in the books of accounts to pay dividend to member societies @20% for the next 25 years.
- ❖ IFFCO operates five major plants in Kalol, Kandla, Phulpur, Aonla and Paradeep with two overseas plants in Oman and Jordan, along with four Nano Fertiliser Plants in India.
- ❖ IFFCO has done strategic diversification though its 21 joint Subsidiaries / Joint Ventures/ Associates.
- ❖ The Board of IFFCO has consistently supported the management in promoting sustainability across its manufacturing plants through process optimization, investment in energy-efficient technologies, and conservation of resources to minimize the environmental footprint.

- ❖ For over two decades, IFFCO has been a proud and active member of the International Co-operative Alliance (ICA), being active member in the forum of initiatives led by ICA.
- ❖ IFFCO representatives have been associated with ICETT as members since its inception.
- ❖ IFFCO, in collaboration with international organisations such as FAO and ICAO, actively works towards the development and advancement of agricultural cooperatives worldwide.
- ❖ During the International Year of Cooperatives (IYC) 2025, IFFCO planted 10,54,120 trees across India to proudly become a “Carbon-Neutral Cooperative”.
- ❖ IFFCO, through its diverse initiatives, contributes to the Sustainable Development Goals (SDGs) by promoting Integrated Nutrient Management via on-farm demonstrations and trials, advancing renewable energy through rooftop solar installations, and delivering agro-technological interventions through IFFCO KISAN SUVIDHA Ltd.






IFFCO in INDIA

Advanced Business Monitoring



Nano Fertilisers

- IFFCO introduced the world's first Nano Fertilisers in 2021 as part of its commitment to sustainable and farmer-centric agriculture.
- Today, IFFCO has developed four Nano Fertilisers—Nano Urea, Nano DAP, Nano Copper, and Nano Zinc.
- These eco-friendly products contribute to minimizing soil and water pollution, promote balanced plant nutrition, enhance crop productivity, and support climate-resilient agricultural practices, by reducing dependence on conventional chemical fertilisers.
- In the year 2024–25, IFFCO produced 45.7 million bottles of Nano fertilisers and sold 36.43 million bottles.
- IFFCO exports this product to 40 Countries and is also establishing a Nano Plant in Brazil with NANOFERT.
